DIRECTOR'S REPORT

Water Line Extension

The job is now complete. We are waiting for a response from the City of Saratoga Springs regarding our connection to the city line. It was agreed that we will shut off their valve and open our valve and send a letter letting them know.

Recent Water Line Breaks and Freeze Ups

Due to the weather we had two frozen water lines located in the homeowner's driveways. One had to be dug up to thaw out the line. The second home in Mulberry Estates had a temporary water line run to avoid digging in the driveway. Two sewer lines froze, one on Sweetbriar and one on Fieldstone. Both were on the homeowner's lines so WWSA had little involvement. We also had a water line break on Carr Road and a sewer line break on Traver Road.

Perry Road Senior Apartments

This will be done in two phases. The first phase is 100 unit building and the second phase is 92 units. It will require a lengthy extension of the water system. They will have their own sewer pump station on site.

Internet Meter Reading System Update

The base station and antenna are in on the tower. We are waiting for Sensus to do programming for the base station and the host were the data will be kept. We should have communications from the new radios to the base station by May. Once the snow clears installation of the new readers will be installed on the homes. Director Mooney has been informed that EJP will no longer be the Sensus representative for New York State. He was reassured that this will not interrupt our installation.

Indian Springs Sewer Upgrade

The project has been delayed due to weather.

Saratoga County Water Quality

Our continual testing has not shown any problems with water quality. The County has raised their rate.

<u>Update Comprehensive Plan</u>

We will start this after the Town has completed their Plan.

Online and Auto Bill Pay

The new meter reading system will have to interface with our existing utility billing system.
