#### Wage and Salary Program

#### DIRECTOR'S REPORT

#### Town Lease

It was discussed and agreed that a 3% per year increase for the lease of office space from the Town of Wilton would be acceptable.

Chairman Fleming asked for a motion to approve the Chairman signing the new lease agreement with the Town of Wilton. Secretary Green offered the following resolution and moved its adoption:

#### County Water Connection Budget

The County stopped pumping water directly into the system. As a result the County water pressure at WWSA connection was too low to enter into the WWSA line. A booster pump at the connection resolved the issue and a budget amendment was approved.

<u>Exit 15 Sewer Improvements</u> The exit 15 pump station is nearing capacity. WWSA will look into upgrading the system.

Floral Estates Area Contract Update

Belmonte Builders will be putting in new houses and will start negotiations with the city of Saratoga Springs and WWSA for a water contract

#### Online and Auto Bill Pay

Credit card payments and deduction from a checking or savings account for WWSA customers are now available online or via phone or office visit. Approximately 177 customers have taken advantage of auto bill pay and many more have paid online using credit/debit cards or e-checks.

#### Board Performance Evaluation for ABO

Each Board Member was given an evaluation form to complete and return. Director Mooney will send them to the ABO.

#### 2010 Law Regarding Phosphates

A new government regulation went into effect July 1, 2010. This new Law limits the use of phosphates in dish washer detergent to .5% from an industry average of 7%. Phosphates ensure several functions in dishwasher detergents, necessary to ensure effective cleaning. Phosphates essentially soften the effects of "hard" water, combining with the minerals in it, mostly calcium and magnesium, thereby eliminating the spots and film on dishes that can form when the minerals and food bits combine during the wash. Phosphates also make the water's pH more alkaline, which helps in food-bit removal.

#### Featherwood Meter Upgrade

The Featherwood customers were sent a notice requesting they make an appointment to have their water meters replaced so the radio read system could be used. Chairman Fleming requested that any other customers without the new radio read system be notified again by Dennis Feeney.
